
NOTE:

- 1.The above fee structure does not include the Hostel fees. At present food and accommodation a sum of Rs.42,000/- per semester is charged separately. This fee depends on fluctuation of prices of essential commodities from time to time.
- 2.Caution Deposit, will be refunded after successful completion of the Course. Charges towards the damages to the physical entities of the University, if any will be deducted.
- 3.Once the payment is made and the receipt is obtained and if the candidate discontinues the course in between, then the amount of refund depends on the **ordinance** governing fee & refund policy of the University/ UGC.
- 4.The Examination Fee and Convocation Fee will be collected separately before the examination as notified by the Registrar-Evaluation, from time to time.
- 5.Additional expenditure payable towards Uniforms, Record books etc. as on requirement will be notified after admission.
